

OFFICIAL TERMS & CONDITIONS FOR THE “BOULDER RUN ALC.CA BONUS MAY 2026” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION (ALC)

The "Boulder Run ALC.ca Bonus May 2026" promotion is available to residents of New Brunswick, Nova Scotia and Newfoundland and Labrador from 00:00:00 Atlantic Time on May 13, 2026, to 23:59:59 Atlantic Time on May 17, 2026. **This promotion is not available to residents of Prince Edward Island.** Participants must have a valid and active alc.ca account.

To earn the \$5 alc.ca bonus, eligible players must, during the Promotion Period, both (1) deposit a cumulative, total amount of at least \$10 into their alc.ca account, and (2) spend a cumulative, total amount of at least \$10 on the Instant Wins game Boulder Run available on alc.ca. Participants can earn a maximum of three (3) \$5 alc.ca bonuses during the Promotion Period.

PROMOTION PERIOD

The promotion will take place between 00:00:00 Atlantic Time on May 13, 2026, to 23:59:59 Atlantic Time on May 17, 2026 (“Promotion Period”).

HOW TO PARTICIPATE

To participate in this promotion:

1. Participants must deposit a total, cumulative amount of at least \$10 into their alc.ca account and spend a total, cumulative amount of at least \$10 on the Instant Wins game Boulder Run available on alc.ca during the Promotion Period.
2. The \$10 deposit and \$10 spend requirements can be met through multiple, cumulative deposits and spends. Promo cash will not be accepted as a funding option for the deposit and spend requirements.
3. The \$10 deposit criteria can only be met by a player manually adding funds to their alc.ca account during the Promotion Period. Online lottery subscriptions and lottery winnings automatically deposited into accounts will not be considered deposits for this promotion.
4. Once all criteria are met, the player will have their \$5 alc.ca bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
5. The offer will run from 00:00:00 Atlantic Time on May 13, 2026, to 23:59:59 Atlantic Time on May 17, 2026.

PROMOTION RULES

1. Eligible participants can earn a maximum of three (3) \$5 alc.ca bonuses during the Promotion Period.

2. Once all criteria are met, the player will have their \$5 alc.ca bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
3. The \$5 alc.ca bonus can be used for alc.ca purchases only. Not exchangeable for cash or cash equivalents.
4. This promotion is non-transferable.
5. Limit of three (3) \$5 alc.ca bonuses per alc.ca member/account.
6. Offer is available to residents of New Brunswick, Nova Scotia and Newfoundland and Labrador only.

DELIVERY OF PRIZES

Once all criteria are met, the player will have their \$5 alc.ca bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
