

## **OFFICIAL TERMS & CONDITIONS FOR THE “INSTANT WINS ALC.CA BONUS FEBRUARY 2026” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION (ALC)**

The "Instant Wins ALC.ca Bonus February 2026" promotion is available to residents of Nova Scotia, New Brunswick, and Newfoundland and Labrador from 00:00:00 Atlantic Time on February 12, 2026, to 23:59:59 Atlantic Time on February 16, 2026. **This promotion is not available to residents of Prince Edward Island.** Participants must have a valid, active and funded alc.ca account.

To earn the \$25 alc.ca Bonus, a player must deposit a total amount of at least \$50 into their alc.ca account and spend a total amount of at least \$25 on Eligible Instant Wins Games available on alc.ca during the Promotion Period. Participants can earn one (1) \$25 alc.ca Bonus during the Promotion Period.

### **PROMOTION PERIOD**

The promotion will take place between 00:00:00 Atlantic Time on February 12, 2026, to 23:59:59 Atlantic Time on February 16, 2026 (“Promotion Period”).

### **HOW TO PARTICIPATE**

To participate in this promotion:

1. Participants must deposit a total, cumulative amount of at least \$50 into their alc.ca account and spend a total, cumulative amount of at least \$25 on Eligible Instant Wins Games available on alc.ca during the Promotion Period.
2. The \$50 deposit and \$25 spend requirements can be met through multiple, cumulative deposits and spends. Promo cash will not be accepted as a funding option.
3. The \$50 deposit criteria can only be met by a player manually adding funds to their alc.ca account. Online lottery subscriptions and lottery winnings automatically deposited into accounts will not be considered deposits for this promotion.
4. Once all criteria are met, the player will have their \$25 alc.ca Bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
5. To participate in the promotion: participants must be 19+; must be a resident of New Brunswick, Nova Scotia or Newfoundland and Labrador; and must have an active and funded alc.ca online account.
6. The offer will run from 00:00:00 Atlantic Time on February 12, 2026, to 23:59:59 Atlantic Time on February 16, 2026.

## **ELIGIBLE INSTANT WINS GAMES**

As part of this promotion, a player must spend a total, cumulative amount of at least \$25 on any of the following games available on alc.ca and/or the Atlantic Lottery app (“Eligible Instant Wins Games”):

## **PROMOTION RULES**

1. Eligible participants can earn one (1) \$25 alc.ca Bonus during the Promotion Period.
2. Once all criteria are met, the player will have their \$25 alc.ca Bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.
3. The \$25 alc.ca Bonus can be used for alc.ca purchases only. Not exchangeable for cash or cash equivalents.

5. Limit of one (1) \$25 alc.ca Bonus per alc.ca member/account.
6. Offer is available to residents of New Brunswick, Nova Scotia and Newfoundland and Labrador only.

Note: Any individual who has falsified their registration information will be ineligible to receive their \$25 alc.ca Bonus.

## **DELIVERY OF PRIZES**

Once all criteria are met, the player will have their \$25 alc.ca Bonus deposited directly into their alc.ca account. This process could take up to 72 hours after the Promotion Period ends.

## **GENERAL RULES**

Classification: Public. This information can be made available to the general public. It may be freely disseminated without potential harm to Atlantic Lottery employees, third parties and stakeholders.

1. alc.ca members who have registered through fraudulent means or have provided false or misleading information will be disqualified. ALC will not be responsible for failed entry attempts for any reason whatsoever.
