

OFFICIAL TERMS & CONDITIONS FOR THE “AL REWARDS OPT-IN BONUS” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION

The "AL Rewards Opt-in Bonus" promotion is available to residents of Nova Scotia, New Brunswick, Prince Edward Island, and Newfoundland and Labrador from 00:00:00 Atlantic Time on January 12, 2026, to 23:59:59 AT on March 31, 2026. Participants must have a valid, active and funded alc.ca account.

To earn 5,000 AL Rewards points, a player must enroll in AL Rewards during the Promotion Period. Each eligible participant can earn a maximum of one (1) bonus of 5,000 AL Rewards points during the Promotion Period.

PROMOTION PERIOD

The promotion will take place between 00:00:00 Atlantic Time on January 12, 2026, and 23:59:59 AT on March 31, 2026 (“Promotion Period”).
